12:30-13:15 Aging and Social Spending

<u>Keynote speech</u>: **Pieter Vanhuysse**, Senior Researcher and Policy Analyst, European Centre for Social Welfare Policy and Research, Austria.

In the past two decades, population aging has accelerated in most OECD democracies as a result of ever-longer life expectancies and continuing low fertility rates. This has led many scholars to predict the advent of 'gerontocracies,' as the increasing voting power is alleged to translate into more generous pension spending and, more generally, into ever more proelderly biased welfare states. This lecture will assess both claims in some detail. First, it will discuss the effects of population aging on both program size and benefit generosity of public pensions in the OECD. The speech will arque that, far from leading to ever more generous pension benefits, population aging leads to the cutting of smaller slices out of larger cakes: it increases overall pension program spending but decreases the generosity of individual benefits. Second, the speaker will widen the discussion to cover altogether eight separate social spending programs as well as a composite indicator of pro-elderly welfare spending bias. The speech will argue that population aging does a better job of explaining social spending within countries than between countries. That is, as a country grows older, it will, not surprisingly, tend to spend more than it used to do on pensions and more generally it will have a higher pro-elderly bias. But interestingly, older OECD countries do not spend significantly more on pensions than younger countries, nor do they have a stronger proelderly bias. To explain such between-country differences, political and institutional factors appear more important than socio-demographic ones.

Hence, it is necessary that institutions promote active aging; that is why, in this Panel, international organisms as well as, American institutions will elaborate on the main features of successful programs in this arena.
