Main responsibilities

- Comparative research in health and long-term care within the current portfolio of the team's activities, in particular integrated care, inequalities in health and care, financing of long-term care, informal care, ageing and public health
- Management (incl. team building, planning, guidance) of the 'Health and Care team' and the related research programme with a focus on international comparative social and health policy research
- Project acquisition (national and international) and project management in the area of health, long-term care and social policies, for instance on workforce development and working conditions in long-term care, quality of care, integrated care etc.
- Participation in the Steering Group and coordination of staff (supervision, mentoring and guidance)
- Participation in on-going international debates in policy and research in health and longterm care
- Coordination, management of and communication with national and international networks of researchers and policy makers
- Dissemination of activities, including through high quality reports, policy briefs, articles in (peer-reviewed) journals and design and organisation of international meetings.

Candidate profile

- PhD or comparable degree with at least eight years of work experience in Social Policy, Political Sciences, Sociology, (Health) Economics, Public Health, Social Gerontology, Psychology or other social sciences
- In-depth understanding of the issues at stake in policy and research on health and longterm care systems, including their organisation, trends, and policy developments, recent reforms and policy debates at the European Union level and in the UNECE Region
- Excellent methodological skills in quantitative and/or qualitative methods of comparative social policy research (incl. quality assurance of related reports and other products)
- Experience in project management and proven skills in coordinating international project teams
- Experience in the acquisition of international research projects (e.g. as Principal Investigator or team lead) would be a key asset
- Track record of related publications and other dissemination activities
