

Georg Fischer is Research Affiliate of the European Centre for Social Welfare Policy and Research, Senior Research Associate at wiiw and a WIFO Associate, focusing on employment and social policies at the European level. He retired from the European Commission in 2017, where his last position was Director for Social Affairs in DG EMP, he was responsible for the development of initiatives related to the Pillar of Social Rights. Earlier in the Commission, he contributed to the European Employment Strategy, worked on the Green and White Papers on Pensions, on policies to facilitate labour market transitions and more recently on policies to address social convergence and divergence. Previously to his work with the European Commission he headed an OECD team preparing labour market reviews in transition economies and served in the Ministries of Finance and Labour in Austria and at the Economic Cooperation Foundation in Tel Aviv. He was a research fellow at the Social Science Center Berlin, at the Yale University Macmillan Center (EU Studies Fellow 2015/2016) and at the Upjohn Institute for Employment Research.
